RESOLUTION NO. 953

A RESOLUTION RESPECTFULLY REQUESTING HIS EXCELLENCY, PRESIDENT AND PRIME MINISTER FERDINAND E. MARCOS, THROUGH THE HONORABLE MINISTER JOSE A. RENO OF LOCAL GOVERNMENT AND COMMUNITY DEVELOPMENT, TO AUTHORIZE THE CITY OF ORMOG TO PROCURE TWO (2) OR MORE SERVICE VEHICLES TO BE PAID OUT OF LOCAL FUNDS

"WHEREAS, with the prosecution of the varied socio-economic development projects of the City Administration geared to the 11 basic needs of man there arises the pressing need for two (2) or more units of service vehicles in order to smoothen the progress of implementation of the program of the Honorable First Lady and Minister of Human Settlements, Madam Imelda Romualdez-Marcos;

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded by Kagawad Santiago; be it

"RESOLVED, to respectfully request His Excellency, President and Prime Minister Ferdinand E. Marcos, through the Honorable Minister Jose A. Reno of Local Government and Community Development, to authorize the City of Ormog to procure two (2) or more units of service vehicles to be paid out of local funds; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Excellency, President and Prime Minister Ferdinand E. Marcos, and the Honorable First Lady and Minister of Human Settlements, Madam Imelda Romualdez-Marcos, both in Malacañang, and Hon. Jose A. Reno, Minister of Local Government and Community Development, all in Metro Manila; and the Regional Director, NLCOD, Tacloban City;
