RESOLUTION NO. 956

RESOLUTION EARNESTLY REQUESTION THE REGIONAL DIRECTOR OF
LOCAL GOVERNMENT AND COMMUNITY DEVELOPMENT, REGION VIII,
TO AUTHORIZE THE CITY OF ORMOC TO UTILIZE THIRTY PERCENT
(30%) OF THE 20% DEVELOPMENT FUND TO BE MADE AVAILABLE
FOR APPROPRIATION FOR BARANGAY BRIGADES PROJECTS AND
INFORMATION DRIVE IN THE AMOUNT OF P73,523.54.

"WHEREAS, the Barangay Brigades have made representations with
this Honorable Body for some financial assistance in the prosecution
of their various projects and information drive;

"NOW, THEREFORE, on motion of Kagawad Besabella, unanimously se-
conded by all the other Mga Kagawad; be it

"RESOLVED, to earnestly request the Regional Director, Ministry
of Local Government and Community Development, Region VIII, to author-
ize the City of Ormoc to utilize thirty percent (30%) of the 20% Deve-
lopment Fund in the amount of Seventy-Three Thousand Five Hundred Twen-
ty-Three & 54/100 Pesos (P73,523.54), said sum or so much thereof as may
be necessary to be made available for appropriation for Barangay Bri-
gades projects and information drive; and be it

the Regional Director, Ministry of Local Government and Community De-
velopment, Region VIII, Tacloban City; the City Treasurer, the City
Budget Officer, and the City Auditor, all in Ormoc City;
