RESOLUTION NO. 965

A RESOLUTION ENDORSING THE CERTIFICATION OF THE HONORABLE CITY
MAYOR ON SOME NOTORIETIES OF CERTAIN MEMBERS OF THE ORMOC CITY
INTEGRATED NATIONAL POLICE TO HIGHER AUTHORITIES FOR INVESTIGATION

"WHEREAS, this august Body has been furnished a copy of the Certification of the Honorable City Mayor to the effect that Police Captain Arnulfo Garciano, Corporals Celso Gementiza, Sozimo Salanap, and Urbano Arradaza, Police First Class Guillermo Flores and Patrolman Sergio Costelo have some connections in illegal activities like selling 'masiao' tips for which they are given daily amounts by financiers, maintaining illegal cockfights in barangays, and some of them molest meat vendors using the name of the Station Commander, harbor bad elements, and indulge in drunkenness, according to reports reaching the Mayor's office;

"WHEREAS, the Honorable City Mayor further certified that Police Corporal Celso Gementiza has been previously investigated in City Fiscals Preliminary Investigation (PI) Case No. 305 for Violation of Circular No. 49, PI Case No. 354 for Less Serious Physical Injuries, PI Case No. 538 for Violation of PD 1602 and PI Case No. 356 for Unjust Vexation which were dismissed;

"WHEREAS, according to the Honorable City Mayor, the above-mentioned members of the Ormoc City Integrated National Police are liabilities to the Local Administration such that the latter would not want them to be assigned in our beloved Ormoc City;

"NOW, THEREFORE, on motion of Kagawad Torrevillas, seconded by all the other Mga Kagawad jointly; be it

"RESOLVED, to endorse the Certification of the Honorable City Mayor on some notorieties of certain members of the Ormoc City Integrated National Police, specially those mentioned above, to higher authorities for investigation;

"CARRIED UNANIMOUSLY."
