"WHEREAS, the City of Ormoc, with its ever-growing population, is in dire need of several fire trucks for distribution to different proposed fire stations where residential buildings abound, not to mention the city's commercial centers which, in case of conflagration, God forbids, our fire truck cannot combat effectively for want of support from other fire engines;
