FIRE TRUCKS FOR THE CITY OF ORMOG

proposed fire stations where residential buildings abound, not to
mention the city's commercial centers which, in case of conflagration,
God forbids, our fire truck cannot combat effectively for want of sup-

lacanang, and Gen. Fidel V. Ramos, PC Chief & INP Director General,
Camp Crame, both in Metro Manila; and the Fire Station Commander, Or-
moc City;
