A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST
CURRENT APPROPRIATION ON SALARIES FOR SUBSTITUTE TEACHERS
OF THE ORMOC CITY HIGH SCHOOL THE AMOUNT OF SEVEN HUNDRED
THIRTY-EIGHT & 92/100 PESOS (P738.92) TO BE MADE AVAILABLE
FOR PAYMENT FOR SERVICES OF MRS. EDENA E. ROA, SECONDARY SCHOOL
SUBSTITUTE TEACHER FROM SEPTEMBER 9 TO NOVEMBER 6, 1980

"WHEREAS, the Ormoc City High School Principal in her letter of
April 23, 1981, has requested this august Body to pass a resolution
charging the amount of Seven Hundred Thirty-Eight & 92/100 Pesos
(P738.92) against current appropriation on salaries for substitute
teachers to pay the services of Mrs. Edena E. Roa, substitute teach-
er, from September 9 to November 6, 1980, inclusive;

Mrs. Edena E. Roa, Secondary School Substitute Teacher, covering the
period from September 9 up to and including November 6, 1980; and be it

Mrs. Edena E. Roa, thru the Principal, Ormoc City High School, the City
Treasurer, and the City Budget Officer, all in the City of Ormoc;
