RESOLUTION NO. 973

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE COMMISSION ON ELECTIONS, THRU THE CITY ELECTION REGISTRAR, TO CONSOLIDATE REGISTRATION OF VOTERS IN BARANGAYS WHERE THERE ARE SCHOOLHOUSES NOW AND ALL OTHER REGISTRATIONS IN NEIGHBORING BARANGAYS WITHOUT SCHOOLHOUSES BE CONSOLIDATED IN ONE APPROXIMATE BARANGAY PRECINCT WHEREVER NECESSARY FOR THE CONVENIENCE OF ELECTORS.

"WHEREAS, with the creation of new barangays in recent years some barangays have already established school buildings while others have none yet such that in the 1980 local elections and in the recently held 1981 plebiscite many electors found difficulties in searching for their names in the voters' lists of either their mother barangays or the newly created ones while still many other electors had to go from one barangay precinct to another looking for their names in order that they could cast their votes; otherwise, they would have been disenfranchised;

"WHEREAS, it would be to their convenience if voters' registration will be consolidated in their respective barangays where there are schoolhouses now while registration in neighboring barangays without schoolhouses will be consolidated in one approximate barangay precinct wherever needed;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded jointly by Mga Kagawad Tugonon and Bandalan; be it

"RESOLVED, to earnestly request the Honorable Commission on Elections, through the City Election Registrar, to consolidate the registration of voters in barangays where there are school buildings now and all other registrations in neighboring barangays without schoolhouses be consolidated in one approximate barangay precinct wherever necessary for the convenience of electors; and be it

"RESOLVED, FURTHER, to furnish copies of this resolution, through the City Election Registrar, to the Honorable Commission on Elections, Metro Manila, and the Provincial Election Supervisor, Tacloban City;
"CARRIED UNANIMOUSLY."
