RESOLUTION NO. 975

A RESOLUTION AUTHORIZING DR. ROGELIO G. MARSON, ASSISTANT CITY  
HEALTH OFFICER, TO UNDERTAKE A 10-MONTH POSTGRADUATE DIPLOMA  
COURSE IN MEDICINE AND PUBLIC HEALTH (MPH - URBAN HEALTH) IN  
BANGKOK, THAILAND, AND PROVIDING HIM HIS SALARY  
FOR THE DURATION OF THE COURSE

"WHEREAS, Dr. Rogelio G. Marson, Assistant City Health Officer,  
in his letter of May 4, 1981, has manifested his desire to avail him-  
self of a study fellowship offered by the Southeast Asian Ministers of  
Education Organization (SEAMEO) Project for Tropical Medicine and Pub-  
lic Health under which he will take a 10-month postgraduate diploma  
course in MPH (Urban Health) provided he can receive his salary for  
the duration;

"WHEREAS, this august Body firmly believes that Dr. Marson's fel-  
lowship will redound to the greater benefit and welfare of the Ormoc  
populace;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded by Kagawad  
Mendola; be it

"RESOLVED, to authorize Dr. Rogelio G. Marson, Assistant City  
Health Officer, to undertake a 10-month postgraduate diploma course  
in Medicine and Public Health (MPH - Urban Health) in Bangkok, Thai-  
land; providing him in this connection his salary for the duration
