RESOLUTION NO. 976

A RESOLUTION TO CHANGE THE NAMES AND/OR VENUES OF THE FIVE NEWLY
CREATED BARANGAYS OF TIPIK, KAUSWAGAN, BLISS & PHASE-IV SQUATTERS'
RELOCATION CENTER SITES, UPPER PATAG, AND LINAO DOS TO BAYOG,
MABATO, BAGONG BUHAY, JUATON, AND LUNA, RESPECTIVELY,
ALL IN THE CITY OF ORMOG

"WHEREAS, the Honorable Cristobal S. Mendola reported that following the creation of the five (5) new barangays of Tipik, Kauswagan, BLISS & Phase-IV Squatters' Relocation Center Sites, Upper Patag, and Linao Dos, a great majority of our constituents therein has been clamoring for a change of the names of their barangays as in the case of Barangay Tipik where the inhabitants like that their barangay be renamed 'BAYOG' which shall be the seat of the barangay government and shall include the sitios out of the portions of Barangays San Jose, Sabang Bao and Quintiguian, while the residents of Barangay Kauswagan which was created from out of the portion of Barangay Curva desire that their barangay be renamed 'MABATO' which shall be the seat of the barangay government and the neighboring sitios or parts thereof under its jurisdiction the territory of which shall be delineated and defined by the City Assessment Department, even as the residents of the BLISS Site and of the Squatters' Relocation Center Site, Phase IV, would like to adopt the name 'BAGONG BUHAY' for their barangay which shall include the former lands of Messrs. Uldarico Panta and Eufrocino Cedula, and the neighboring areas;

"WHEREAS, according to Kagawad Mendola, there is a need to change the venues of the newly created barangays of Upper Patag and Linao Dos whereby Upper Patag ought to have been 'JUATON' comprising Juaton, itself, as the seat of the barangay government, and the sitios or portions of Barangays Dayhagan and Concepcion (Catayun) and, also, Linao Dos should have been 'LUNA' comprising Luna, itself, as the seat of the barangay government, and certain sitios or portions of Barangays Dolores and San Pablo (Simangan);

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kagawad Torrevillas; be it

"RESOLVED, to change the names and/or venues of the five (5) newly created barangays and define their territorial jurisdictions, respectively, to wit:
