RESOLUTION NO. 981

A RESOLUTION EARNESTLY REQUESTING THE NATIONAL ELECTRIFICATION  
ADMINISTRATION FOR LEYECO V. NOW TO REDUCE ITS RATE TO P0.61  
PER KILOWATT-HOUR CONSIDERING THAT THE COOPERATIVE'S LOSSES  
INCURRED DUE TO FULL USE OF ORMOG ELECTRIC COMPANY (ORELCO)  
POWER MUST HAVE BEEN ALREADY MORE THAN FULLY RECOVERED

"WHEREAS, with the full operation last year of the National Power Corporation's pilot generating plant in Tugonon we were supposed to enjoy a reduced rate of P0.61 per kilowatt-hour had it not been for the untimely bogging down of the NPC power plant such that power then had to be supplied by the Ormoc Electric Company (ORELCO) charging P0.913 per kilowatt-hour whereby, with the approval of the National Electrification Administration, the Cooperative has been charging the new rates of P0.65 per kilowatt-hour plus additional fuel cost adjustment (FCA) of P0.6046 per kilowatt-hour effective July, 1980, in view of the alleged considerable losses incurred due to the full use of the ORELCO power;

"WHEREAS, when the NPC Tugonon power plant resumed operation last September there was some sort of agreement that in nine months' time the rate will be reduced to P0.61/KWH and, believing that the losses have already been more than fully recovered specially so now with the expansion of LEYECO V's services to Albuera, Merida, Kananga and Matag-ob municipalities, it is about time that said rate be reduced;

"NOW, THEREFORE, on motion of Kagawad Santiago, unanimously seconded by all the other Mga Kagawad; be it

"RESOLVED, to earnestly request the National Electrification Administration for LEYECO V now to reduce its rate to P0.61 per kilowatt-hour considering that the Cooperative's losses incurred due to the full use of the Ormoc Electric Company (ORELCO) power must have already been more than fully recovered; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Col. Pedro Dumol, Administrator, NEA, Quezon Ave., Quezon City; the General Manager and the Board President, LEYECO V, both in Ormoc City;  
"CARRIED UNANIMOUSLY."
