RESOLUTION NO. 983

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST  
THE ITEM ON YOUTH AND SPORTS DEVELOPMENT THE SUM OF SIX  
HUNDRED EIGHTY & 50/100 PESOS (P680.50) TO BE MADE AVAILABLE  
FOR REIMBURSEMENT OF ACTUAL AND NECESSARY TRAVEL AND TRANSPORTA-  
TION EXPENSES OF KB REPRESENTATIVE EMMANUEL P. ESMERO TO THE  
NATIONAL KB LEADERSHIP TRAINING-SEMINAR IN LOS BAÑOS, LAGUNA

"WHEREAS, Mr. Emmanuel P. Esmero, who has been authorized by the  
Regional Youth Development Director to represent the Kabatang Barangay  
President to participate in the National KB Leadership Training-Seminar  
on October 25-31, 1980, at Camp September 21st Movement, Mt. Makiling,  
Los Baños, Laguna, has requested a reimbursement for his actual and  
necessary traveling expenses thereto in the sum of six hundred eighty  
pesos and fifty centavos which may be taken from a portion of the 20%  
Economic Development Fund or any other local fund available as author-  
ized by the Regional Director of the Ministry of Local Government and  
Community Development;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded jointly  
by Mga Kagawad Mendola and Bandalan; be it

"RESOLVED, to authorize the City Treasurer to charge against the

Camp September 21st Movement, Mt. Makiling, Los Baños, Laguna; and be it
