RESOLUTION NO. 987

A RESOLUTION RESPECTFULLY REQUESTING AMBASSADOR ROBERTO BENEDICTO TO REQUEST PROPER AUTHORITIES THAT CLOUD-SEEDING BE MADE IN ORMOC CITY TO INDUCE RAINS FOR SURVIVAL OF SUGARCANE AND OTHER PLANTATIONS IN THE AREA

"WHEREAS, for the last three months we have been experiencing a drought such that our sugarcane and other crops are very much affected and if no rains will be forthcoming soon these crops will be greatly damaged which will ultimately cause so much economic dislocation not only in Ormoc City but also in the neighboring municipalities;

"WHEREAS, sugarcane planters and other farmers have made representations with this august Body for the feasibility of requesting proper authorities in the National Government, through the Honorable Ambassador Roberto Benedicto, for some cloud-seeding in Ormoc City with the hope that rains may be induced in order that our crops will survive the on-slaught of the drought;

"NOW, THEREFORE, on motion of Kagawad Torrevillas, seconded by Kagawad Bandalan; be it

"RESOLVED, to respectfully request the Honorable Ambassador Roberto Benedicto to help our planters and farmers request proper authorities that cloud-seeding be made in Ormoc City to induce rains for the survival of sugarcane and other plantations in the area;

"RESOLVED, FURTHER, to furnish a copy of this resolution to the Honorable Ambassador Roberto Benedicto, Chairman, Philippine Sugar Commission, North Avenue, Dilliman, Quezon City;
