RESOLUTION NO. 989

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT
THE DONATION OF TWO UNITS OF 80-WATT BALLASTED TYPE
MERCURY VAPOR LAMPS, COMPLETE WITH ACCESSORIES, FROM
THE YOUTH ORGANIZATION OF BARANGAY DISTRICT XXII, FOR
INSTALLATION ON POLES NOS. 1 and 18, ON SAN JOAQUIN
AND RIZAL STREETS, RESPECTIVELY, AND THANKING THE
DONORS FOR THEIR CIVIC-SPIRITEDNESS

"WHEREAS, the Youth Organization of Barangay District XXII,
by the President, has signified their intention, in a letter dated
25 May 1981, to donate two (2) units of 80-watt ballasted type mer-
