RESOLUTION NO. 990

A RESOLUTION EARNESTLY REQUESTING THE COMMANDING OFFICER, EASTERN  
COMMAND, FOR THE TOTAL AND IMMEDIATE WITHDRAWAL OF THE POLICE  
FORCE FROM ORMOG CITY FOR THE BETTER MAINTENANCE OF PEACE AND  
ORDER AND FOR THE BETTER PROTECTION OF LIFE AND PROPERTY IN  
THIS LOCALITY WITH THE ORGANIZATION OF THE ORMOG CITY  
HOME GUARD OR THE NEIGHBORHOOD ASSOCIATION

"WHEREAS, the City Administration is already fed up with the apathy  
and impotence of all the officers and members of the city police force in  
their prime and paramount duty of maintaining peace and order in this ju-  
risdiction aggravated by wilfull negligence and irregularities in the per-  
formance of duty by the force resulting in the loss of confidence by the  
entire residents in this bunch of incorrigibles;

"WHEREAS, it is the sincere and honest belief of this Body that peace  
and order could be maintained better in Ormoc City without the services of  
the police department and it is preferable to organize the Ormoc City Home  
Guard or the Neighborhood Association;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded unanimously  
by all the other Mga Kagawad; be it

"RESOLVED, to earnestly request the Commanding Officer, Eastern Com-  
mand, for the total and immediate withdrawal of the police force from Or-  
moc City for the better maintenance of peace and order and for the better  
protection of life and property in this locality with the organization of  
the Ormoc City Home Guard or the Neighborhood Association; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His  
Excellency, President and Prime Minister Ferdinand E. Marcos, and the Ho-  
norable First Lady and Human Settlements Minister Imelda-Romualdez-Marcos,  
the Honorable National Defense Minister Juan Ponce Enrile, INP Director  
General Fidel V. Ramos, all in Metro Manila; the Honorable Governor Benja-  
min Romualdez, Tacloban City; Gen. Salvador Mison, Commanding Officer, Eas-  
tern Command, Catbalogan Samar; Col. Cesar Villarin, Camp September 21st  
Movement, and Col. Eddie Foronda, Port Area, both in Tacloban City; and  
Lt. Ronald Roderos, Commanding Officer, 352nd PC Company, Ormoc City;
