RESOLUTION NO. 992

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN THE DEED OF SALE WITH ROSALIA TAN-TOMADA AND ROSEMARIE TAN TOMADA COVERING 2½ HECTARES OF THE LATTER'S LOT NO. 4486-A-2 SITUATED AT BARANGAY SIMANGAN FOR PURPOSES OF THE PROVINCIAL ACTION CENTER OF THE MINISTRY OF HUMAN SETTLEMENTS AVAILING IN THIS CONNECTION THE SUM OF ₱75,000.00 PROVIDED FOR PER ITEM NO. 1 UNDER APPROPRIATION ORDINANCE NO. 81-7

"WHEREAS, there is now being prepared the deed of sale to be signed by His Honor, the City Mayor, for and in behalf of the City Government, and Rosalia Tan-Tomada with daughter Rosemarie Tan Tomada covering two-and-one-half (2½) hectares of the latter's Lot No. 4486-A-2 situated at Barangay Simangan which is now being utilized by the City for purposes of the Provincial Action Center of the Ministry of Human Settlements;

"WHEREAS, the owners of the land have agreed to sell the area at ₱30,000.00 per hectare for which the City had already appropriated the sum of ₱75,000.00 under Appropriation Ordinance No. 81-7, more particularly, Item No. 1 thereof;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kagawad Torrevillas; be it

"RESOLVED, to authorize the Honorable City Mayor, for and in behalf of the Government of Ormoc City, to sign the deed of sale with Rosalia Tan-Tomada and Rosemarie Tan Tomada covering two-and-one-half (2½) hectares of the latter's Lot No. 4486-A-2 situated at Barangay Simangan for purposes of the Provincial Action Center of the Ministry of Human Settlements availing in this connection the sum of ₱75,000.00 provided for per Item No. 1 under Appropriation No. 81-7; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Auditor, and Mrs. Rosalia Tan-Tomada, all in Ormoc City;
