A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT THE
DONATION OF THE NORTHERN PORTION COVERING ONE (1) HECTARE OF
LOT NO. 2 OF THE CONSOLIDATION AND SUBDIVISION PLAN (IRC)
POS-16778 COVERED BY TCT NO. 11335 BY MRS. FELIZA ZAMORA VDA.
DE MEJIA SITUATED IN BARANGAY TUOG, ORMOC CITY, FOR BARANGAY
SCHOOL SITE PURPOSES AND THANKING THE DONOR FOR HER GENEROSITY

"WHEREAS, Mrs. Feliza Zamora vda. de Mejia is donating one (1)
hectare of her Lot No. 2 of the consolidation and subdivision plan
(IRC) Pos-16778, more particularly, the northern portion situated in
Barangay Tu-og, this city, to be made available for school site of
the said barangay, which lot is covered by TCT No. 11335 of the Re-
gister of Deeds of Ormoc City;

"WHEREAS, the City Administration owes Mrs. Mejia a debt of
gratitude for her generosity in so donating a lot for the benefit
and welfare of the barangay residents of Tu-og in particular, and
the City of Ormoc in general, specially for the youth who will be the
greater beneficiaries with the establishment of a barangay schoolhouse;

ly by all the other Nga Kagawad; be it

"RESOLVED, to authorize the Honorable City Mayor to accept the
donation of the northern portion covering one (1) hectare of Lot No.
2 of the consolidation and subdivision plan (IRC) Pos-16778 situated
in Barangay Tu-og and covered by Transfer Certificate of Title No.
11335 by Mrs. Feliza Zamora vda. de Mejia for barangay school site
purposes and do, as this Body hereby does, express our heartfelt
thanks to the donor for her generosity which will go a long way to-
wards the education and development of the youth in the barangay;
