RESOLUTION NO. 998

A RESOLUTION AUTHORIZING THE BARANGAY COUNCIL OF CATMON TO SEGREGATE 6,271 SQUARE METERS OUT OF THE BARANGAY SCHOOL SITE ON CITY GOVERNMENT LOT NO. 8218-B TO BE MADE AVAILABLE FOR BARANGAY SITE PROVIDED THAT IT WILL BE SUBDIVIDED SUBJECT, HOWEVER, TO GOVERNING POLICY RATIFIED BY THE SANGGUNIANG PANLUNGSOD NG ORMOC

"WHEREAS, the Barangay Council of Catmon by its unnumbered resolution of June 5, 1981, has requested the City Administration an area of 6,271 square meters out of the barangay school site on Lot No. 8218-B owned by the City Government, said area to be made available for a barangay site thereby leaving 5,000 square meters for the school site;

"WHEREAS, this august Body would like to grant the request of the Catmon Barangay Council provided that the area for barangay site shall be subdivided with provisions for government and recreation or sports centers and the like subject, however, to government policy ratified by the Sangguniang Panlungsod ng Ormoc;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kagawad Torrevillas; be it

"RESOLVED, to approve the resolution dated June 5, 1981, of the Barangay Council of Catmon and do, as this Body hereby does, authorize said council to segregate 6,271 square meters out of the Barangay School site on City Government Lot No. 8218-B to be made available for barangay site of Catmon provided that it will be subdivided subject, however, to governing policy ratified by the Sangguniang Panlungsod ng Ormoc; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Barangay Council of Catmon, Hon. Dionisio B. Torrevillas, Kagawad In-Charge, and Hon. Cristobal S. Mendola, Chairman on Public Properties, Sangguniang Panlungsod, all in the City of Ormoc;
