CURRENT APPROPRIATION ON WATER SERVICES OF THE SANGGUNIANG PAN-  
LUNGSOD NG ORMOC THE LATTER OFFICE'S OUTSTANDING OBLIGATION OF  
P420.00 FOR THE PERIOD JUNE-DECEMBER, 1981, PER WATER BILL #122

"WHEREAS, the Office of the City Treasurer, by the Water Meter  
Reader-Collector, has billed the Sangguniang Panlungsod ng Ormoc in  
the sum of P420.00 for water services covering the period from June  
to December, 1981, at the flat rate of P60.00 per month, per Water  
Bill No. 122 dated December 14, 1981;
