RESOLUTION NO. 1092

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO PURCHASE
SOME 7400 SQUARE METERS OF THE LOT OF ASPRAC AGRICULTURAL
CORPORATION IN BARANGAY PATAG FOR PURPOSES OF AN
ADDITIONAL SQUATTERS' RELOCATION CENTER
AT THE RATE OF P3.00 PER SQUARE METER

"WHEREAS, we need to relocate about 25 squatter-families along
the Malbasag river dike bordering on San Pablo Street in order to
clear this area abutting the Ormoc City Central School ground; and

"WHEREAS, upon negotiations with Mr. Agapito Pongos of the AS-
PRAC Agricultural Corporation he was willing to part with some 7400
square meters of the corporation's lot which is adjacent to the pre-
sent relocation center in Barangay Patag at the rate of P3.00 per
square meter;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Ka-
gawad Torre Villas; be it

"RESOLVED, to authorize the Honorable City Mayor to purchase
some 7400 square meters of the lot of ASPRAC Agricultural Corpora-
tion situated in Barangay Patag and adjacent to the present reloca-
tion center for squatters at the rate of three pesos (P3.00) per
square meter, said lot to be made available for additional reloca-
tion center for squatters; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the City Treasurer, the City Auditor, the City Engineer, and Mr.
Agapito S. Pongos, ASPRAC Agricultural Corporation, all in Ormoc City;
"CARRIED UNANIMOUSLY."
