RESOLUTION NO. 1093

A RESOLUTION REQUESTING THE PC REGIONAL COMMANDER, THROUGH THE
PROVINCIAL COMMANDER, TO AUTHORIZE THE ORMOG CITY SCOUTING
COMMITTEE, BSP, TO SPONSOR A 3-DAY "PINTAKASI" (FEB. 11-13,
1982) AT THE VALENCIA SPORTS CENTER, ORMOG CITY, TO RAISE
FUNDS FOR THE FORTHCOMING JAMBO-RALLY IN MARCH, 1982

"WHEREAS, the Barangay Captain of Valencia who is also the Chairman
of the Scouting Committee, Boy Scouts of the Philippines, Ormoc City North
District, in his letter of January 7, 1982, has, through the Honorable Ma-
yor and the Presiding Officer, requested a resolution allowing them to hold
or sponsor a three-day 'pintakasi' on February 11-13, 1982, at the Valencia
Sports Center, as part of their fund-raising drive for the forthcoming Boy

ter, Barangay Valencia, all in Ormoc City;
