RESOLUTION NO. 1094

A RESOLUTION AUTHORIZING THE CITY TREASURER TO EXTEND THE  
DEADLINE FOR PAYMENT OF MAYOR'S PERMIT FEES AND CITY  
LICENSES FROM JANUARY 20 TO JANUARY 31, 1982

"WHEREAS, quite a number of taxpayers had made representations  
for the extension of the deadline for payment of Mayor's permit fees  
and city licenses from January 20 to January 31, this year;

"WHEREAS, the request partakes of a temporary suspension of ope-  
ration of Section 1.2.1.4 of Tax Ordinance No. 1, otherwise known as  
the Ormoc City Revenue Code, fixing the first twenty (20) days of Ja-  
nuary to pay tax obligations;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by  
Kagawad Samson; be it

"RESOLVED, to authorize the City Treasurer to extend the dead-  
line for payment of Mayor's permit and city licenses fees from Janu-  
ary 20 to January 31, 1982, suspending for this purpose temporarily  
Section 1.2.1.4 of Tax Ordinance No. 1, otherwise known as the Ormoc  
City Revenue Code; and be it

City Treasurer and his City Licenses Clerks, Ormoc City;
