RESOLUTION NO. 1096

A RESOLUTION EARNESTLY REQUESTING THE MINISTRY OF HUMAN  
SETTLEMENTS, THROUGH THE REGIONAL KKK ACTION OFFICER,  
TO GRANT P.R.O. FELIZARDO F. TUGONON A MONTHLY HONORARIUM  
FOR SERVICES RENDERED AS ORMOC CITY KKK ACTION OFFICER

"WHEREAS, Mr. Felizardo F. Tugonon, Public Relations Officer of  
the Office of the Mayor, had sought the assistance of this august Bo-  
dy in requesting the Ministry of Human Settlements, through Dr. Pedro  
D. Destura, Regional KKK Action Officer, for a monthly honorarium in  
his capacity as KKK Action Officer of Ormoc City considering that, ac-  
cording to him, most if not all of the city and municipal KKK action  
officers have been receiving each a monthly honorarium of P500.00 ever  
since the start of the KKK program implementation;

"WHEREAS, this august Body finds the request of the Public Rela-  
tions Officer and concurrently KKK City Action Officer most worthy of  
our consideration taking into account that he has been incurring ex-  
penses in traveling to the different barangays on invitation by baran-  
gay captains and MEC officials to disseminate the KKK information;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded by  
Kagawad Santiago; be it

"RESOLVED, to earnestly request the Ministry of Human Settlements,  
through the Regional KKK Action Officer, to grant P.R.O. Felizardo F.  
Tugonon a monthly honorarium for services rendered as Ormoc City KKK  
Action Officer; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each  
to the Ministry of Human Settlements, Metro Manila, through Dr. Ped-  
ro D. Destura, Regional KKK Action Officer, Tacloban City, and Mr.  
Felizardo F. Tugonon, Public Relations Officer, Office of the Mayor,  
Ormoc City;

"CARRIED. Seven affirmative votes; one abstention registered by  
the Floor Leader, Kagawad Benjamin F. Tugonon."
