RESOLUTION NO. 1099

A RESOLUTION EARNESTLY REQUESTING THE MANAGER OF LEYTE GEOTHERMAL PROJECT TO FAVORABLY RECOMMEND THE RELEASE OF THE 31-HECTARE PORTION OF LOT NO. 10851 IN CABINGTAN, ORMOG CITY, UNDER THE CITY'S LEASE APPLICATION WITH THE BUREAU OF LANDS FOR PURPOSES OF THE "PAGKAIN NG BAYAN" PROJECT AND FOR VEGETABLE NURSERY IN LINE WITH THE NEED OF THE KKK PROGRAMS OF ORMOG CITY

"WHEREAS, the City Government's lease application covering some 31 hectares out of Lot No. 10851, Cad. 256, in Cabingtán for purposes of the City Nursery is being held pending by the Bureau of Lands while waiting for the comment of the Manager of Leyte Geothermal Project on the positivity of geothermal power in the area and its use by the PNOG for and within the next 10 years even as the original and duplicate copies of the survey plan of the area desired to be leased by the City is still under scrutiny and awaiting his signature;

"WHEREAS, the area applied for, if released, will be devoted to vegetable nursery and for purposes of the 'Pagkain ng Bayan' project in line with the need of the KKK programs of Ormoc City and, if ever PNOG desires to take it back in some future time, the area can be immediately cleared and made ready for its use again;

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded jointly by Mga Kagawad Mendola and Samson; be it

"RESOLVED, to earnestly request the Manager of Leyte Geothermal Project to favorably recommend the release of the 31-hectare portion of Lot No. 10851, Cad. 256, in Cabingtán, Ormoc City, under the City's lease application with the Bureau of Lands for purposes of the 'Pagkain ng Bayan' project and for vegetable nursery in line with the need of the KKK programs of Ormoc City; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the District Land Officer, Bureau of Lands, Tacloban City, and Engr. Ernesto B. Patanao, Manager, Leyte Geothermal Project, PNOG, Ormoc City;
