RESOLUTION NO. 1103-A

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT THE
DONATION OF 3 BALLASTED TYPE MERCURY LAMPS OF DOMISIDE VILLAGE,
COGON COMBADO, FOR INSTALLATION ON 3 ALTERNATE ELECTRIC POSTS
ALONG FAUSTINO ABLEN STREET PROVIDED THAT THE MAINTENANCE SHALL
BE SHOULDERED BY THE BARANGAY COUNCIL OF COGON COMBADO

"WHEREAS, the Barangay Captain, by his Councilman-Officer In-
Charge, of Cogon Combado, this city, has favorably forwarded Reso-
lution No. 3 of Domiside Village signifying their intention to do-
nate 3 units of ballasted type mercury lamps for installation on 3
alternate electric posts along Faustino Ablen Street;

"WHEREAS, this august Body finds the donation acceptable on
condition that the said installations shall be maintained by the
Barangay Council of Cogon Combado in pursuance of the policy of
the City Administration;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by
Kagawad Bandalan; be it

"RESOLVED, to authorize the Honorable City Mayor to accept
the donation of 3 ballasted type mercury lamps of Domiside Village,
Cogon Combado, for installation on 3 alterante electric posts along
Faustino Ablen Street: Provided, However, that the maintenance shall
be shouldered by the Barangay Council of Cogon Combado on the said
installations; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the Barangay Captain and the President, Domiside Village, both
of Cogon Combado, the President, Board of Directors, and the Gene-
ral Manager, both of LEYECO V, and all of Ormoc City;

"CARRIED UNANIMOUSLY."
