A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST  
CURRENT APPROPRIATION ON AID TO COURT OF AGRARIAN RELATIONS  
THE SUM OF ₱1,200.00 TO SETTLE OUTSTANDING OBLIGATIONS OF THE  
COURT ON BUILDING RENTALS WITH MR. AGAPITO PONGOS FOR THE PE-  
RIOD FROM SEPTEMBER TO DECEMBER, 1981, AT ₱300 PER MONTH

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Men-  
dola, Seconded by Kagawad Samson;

"RESOLVED, to authorize the City Treasurer to charge against the  
current appropriation on Aid to Court of Agrarian Relations the sum

the rate of ₱300.00 per month; and

Agrarian Relations, and Mr. Agapito Pongos, all in Ormoc City;
