RESOLUTION NO. 1105

A RESOLUTION EARNESTLY REQUESTING RECONSIDERATION OF THE RULING
OF THE ACTING ASST. REGIONAL DIRECTOR, BUREAU OF FOREST
DEVELOPMENT, ON OUR RESOLUTION NO. 860

"WHEREAS, the Acting Assistant Regional Director, Bureau of Forest
Development, has denied our request embodied in Resolution No. 860 dat-
ed August 12, 1980, to set aside ten (10) hectares of the open space in
the vicinity of Gaas-Lake Imelda junction for the construction of an
all-purpose center;

"WHEREAS, the area applied for is the very same open space where
the Boy Scouts Jamboree of September 11-16, 1979, was held and the City
does not intend to cut trees in the immediate vicinity even as we believe
that the ecological balance of the community can still be maintained and
its natural beauty as wilderness area can always be preserved mindful as
we are that the area is a National Park and a tourist spot;

"WHEREAS, in reiterating, the all-purpose center to be constructed
in the open space which was the 1979 Boy Scouts Jamboree site will accom-
modate buildings for recreation, sports, convention, cultural and all
other centers of development;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded unanimously
by all the other Mga Kagawad present; be it

"RESOLVED, to earnestly request reconsideration of the ruling of
the Acting Assistant Regional Director, Bureau of Forest Development,
on our Resolution No. 860 dated August 12, 1980, and do, as this Body
hereby does, reiterate our request to set aside for Ormoc City Govern-
ment the 10-hectare open area which was the 1979 Boy Scouts Jamboree
site situated within the immediate vicinity of Gaas-Lake Imelda Junc-
tion for the establishment of an all-purpose center; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the National Director, Bureau of Forestry, Bureau of Forest Developm-
ent, Cubao, Quezon City; the Asst. Regional Director, BFD, Tacloban
City, the Officer-In-Charge, BFD, Punta, and the Officer-In-Charge,
Lake Imelda Park, all in Ormoc City;
