RESOLUTION NO. 1106

A RESOLUTION MOST RESPECTFULLY REQUESTING THE HONORABLE FIRST LADY AND HUMAN SETTLEMENTS MINISTER, MADAM IMELDA ROMUALDEZ MARCOS, TO INTERCEDE FOR AND IN BEHALF OF THE CITY OF ORMOG WITH THE BUREAU OF FOREST DEVELOPMENT TO SET ASIDE THE TEN-HECTARE OPEN SPACE WHICH WAS THE 1979 BOY SCOUTS JAMBOREE SITE IN THE IMMEDIATE VICINITY OF GAAS-LAKE IMELDA JUNCTION FOR THE ESTABLISHMENT OF AN ALL-PURPOSE CENTER.

"WHEREAS, the Acting Assistant Regional Director, Bureau of Forest Development, has not favorably granted our request to set aside the 10-hectare open space which was the camp site of the 1979 Boy Scouts Jamboree in the immediate vicinity of Gaas-Lake Imelda on which the City Government is interested to establish an all-purpose center that will accommodate buildings for a recreation center, sports, convention, cultural and all other centers of development;

"WHEREAS, the City does not intend to cut trees in the vicinity of this open space and we believe that the ecological balance of Lake Imelda can still be maintained while its natural beauty as a wilderness area can always be preserved considering that this area is a National Park and a tourist spot;

"NOW, THEREFORE, on motion of Kagawad Santiago, seconded unanimously by all the other Kagawad present; be it

"RESOLVED, to most respectfully request the Honorable First Lady and Human Settlements Minister, Madam Imelda Romualdez-Marcos, to intercede for and in behalf of the City of Ormoc with the Bureau of Forest Development to set aside the ten-hectare open space which was the 1979 Boy Scouts Jamboree site in the immediate vicinity of Gaas-Lake Imelda junction for the establishment of an all-purpose center; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Madam Imelda Romualdez-Marcos, Malacañang; the National Director, Bureau of Forest Development, Cubao, C.C., both in Metro Manila; the Asst. Regional Director, BFD, Tacloban City; the Officer-In-Charge, BFD, Punta, and the Officer-In-Charge, Lake Imelda Park, both in Ormoc City;
