RESOLUTION NO. 1112

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE MINISTER
JESUS HIPOLITO OF PUBLIC WORKS AND HIGHWAYS TO RETAIN
ENGR. SALVADOR S. SANTIAGO AS CITY ENGINEER OF ORMOC

"WHEREAS, this august Body is filled with apprehension over the current revamping and reshuffling of officials of the Ministry of Public Works and Highways such that we dread the day that Engr. Salvador S. Santiago might be included among those to be reassigned somewhere else leaving behind him unfinished infrastructure projects of varying degrees which are on-going up to this very moment, not to mention the future projects as envisioned and planned by the City Administration with which we trust the expertise and techniques of Engr. Santiago in the prosecution of projects one after another and for which reason we do like to hold him longer just so we could still avail ourselves of his talent and ingenuity for the ultimate benefit and welfare of our very own Ormoc City;

"NOW, THEREFORE, on motion of Kagawad Besabella and, also, of Kagawad Hermosilla representing the Association of Barangay Councils, seconded unanimously by all the other Mga Kagawad; be it

"RESOLVED, to earnestly request the Honorable Jesus Hipolito, Minister of Public Works and Highways, to retain Engr. Salvador S. Santiago as City Engineer of Ormoc and do, as this Body hereby does, reflect this resolution in a telegram immediately to the Honorable Minister; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Hon. Jesus Hipolito, Minister of Public Works and Highways, Port Area, Metro Manila; the Regional Director, Ministry of Public Works and Highways, Tacloban City; and Engr. Salvador S. Santiago, Highway District Engineer II, Officer-In-Charge, Engineering Department, Ormoc City;
