RESOLUTION NO. 1117

A RESOLUTION TO ALLOW THE EASTERN VISAYAS TRANSPORTATION COMPANY
(EV-TRANCO) TO INSTALL A SINGLE-SIDE-BAND (SSB) RADIO COMMUNI-
CATION SYSTEM AT THE ORMOC CITY BUS TERMINAL BUILDING NO. 2
PROVIDED IT SHALL NOT DESTROY ANY PART OF THE BUILDING

"WHEREAS, Mr. Frank N. Thomas, operation officer of the Eastern
Visayas Transportation Company (EV-TRANCO), in his letter of Februa-
ry 7, 1982, has requested the City Government of Ormoc, for and in
behalf of the PANTRANCO SOUTH, that they be allowed to install a sin-
gle-side-band radio communication system at the city terminal build-
ing for purposes of their official and commercial communications bet-
ween Ormoc City, the central office in Pasay City, and their main of-
fice in Tacloban City;

"WHEREAS, this august Body finds the request of the EV-TRANCO
Operation Officer most worth of our consideration inasmuch as an SSB
radio communication system will bring his office much closer to Ormoc
City and Pasay City and will redound ultimately to the convenience
and general well-being of Ormoc passengers commuting to Metro Manila;

"NOW, THEREFORE, on motion of Kagawad Santiago, seconded jointly
by Mga Kagawad Samson and Hermosilla; be it

"RESOLVED, to allow the Eastern Visayas Transportation Company
(EV-TRANCO) to install a single-side-band (SSB) radio communication
system at the Ormoc City Bus Terminal Building No. 2: PROVIDED, How-
ever, That the said installation shall not in one way or another des-
troy or cause damage to any part of the said terminal building; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
Mr. E. H. Sison, Division Operations Manager, and Mr. L. B. Cruz, Jr.,
Actg. Asst. Vice-President for Operations, both of Pantranco South,
Pasay City; Mr. Frank N. Thomas, Operations Officer, EV-TRANCO, Tac-
loban City; and the Resident Manager, EV-TRANCO, Ormoc City;
