AT THE SQUATTERS' RELOCATION CENTER IN BARANGAY PATAG.

"WHEREAS, the residents of the CCF Village Development Area and
of the Squatters' Relocation Center in Barangays Linao and Patag, re-
spectively, have been clamoring for distribution lines of LEYECO V in
order that they could enjoy more and better electrification;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded joint-
ly by Mga Kagawad Mendola and Santiago; be it

"RESOLVED, to earnestly request the General Manager of LEYECO V
to install as soon as possible distribution lines at the CCF Village
Development Area in Barangay Linao and, also, at the Squatters' Relo-
