RESOLUTION NO. 1123

A RESOLUTION FAVORABLY ENDORSING TO THE BUREAU OF LAND  
TRANSPORTATION THE PETITION OF PANTRANCO SOUTH TO OPERATE  
SIX ADDITIONAL UNITS FOR IMPLEMENTATION OF THEIR EXPANSION  
PROGRAM ALONG THE PASAY-ALLEN-TACLOBAN-ORMOC ROUTE

"WHEREAS, Mr. Frank N. Thomas, Operations Officer, Eastern Visayas Transportation Company, for and in behalf of the mother company, Pantranco South, personally made representations before this august Body requesting favorable endorsement of the company's petition with the Bureau of Land Transportation in connection with their expansion program by adding six units en route from Pasay City to Ormoc City through Allen, Northern Samar, and Tacloban City and back;

"WHEREAS, this august Body finds the request most worthy of accommodation considering that Ormoc City and neighboring municipalities down south are in dire need of direct overland transportation facilities from Pasay City or Metro Manila, for that matter, even as the Eastern Visayas Transportation Company (EV-TRANCO), in coordination with Pantranco South, is willing to render reliable, safe, convenient and secured services to the traveling public whereby EV-TRANCO will effectively be instrumental in enhancing the economic development and progress of not only Ormoc City but also the neighboring towns down to Southern Leyte;

"NOW, THEREFORE, on motion of Kagawad Santiago, seconded jointly by Mga Kagawad Mendola, Besabella, Samson, Bandalan, and Hermosilla; be it

"RESOLVED, to favorably endorse to the Bureau of Land Transportation the petition of PANTRANCO SOUTH for the latter to operate additional six units for purposes of implementation of their expansion program along the Pasay-Allen-Tacloban-Ormoc route; and be it
