A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO CHARGE AGAINST
CURRENT APPROPRIATION ON REPAIR AND MAINTENANCE OF CITY
ROADS AND BRIDGES THE SUM OF P940.80 TO COVER UP DEFICIENCY
OF APPROPRIATION FOR LUMBER USED IN CONNECTION WITH THE
EMERGENCY REPAIR OF CONCEPCION BRIDGE

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad San-
tiago, seconded jointly by Mga Kagawad Samson and Hermosilla;
