A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST  
CURRENT APPROPRIATION ON AID TO REGISTER OF DEEDS THE SUM  
OF TWO HUNDRED SEVENTY PESOS TO SETTLE ITS OUTSTANDING  
OBLIGATIONS ON TELEPHONE RENTALS FROM MARCH TO JULY, 1981  
WITH THE BUREAU OF TELECOMMUNICATIONS' TELEPHONE EXCHANGE
