RESOLUTION NO. 1136

A RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE MINISTER OF
EDUCATION AND CULTURE TO EXPEDITE THE RELEASE OF THE 40%
NATIONAL SHARE OF THE ORMOG CITY HIGH SCHOOL TEACHERS'
SALARIES FROM THE LAST QUARTER OF 1981 TO DATE IN ORDER
TO ALLEVIATE THE FINANCIAL SUFFERING OF THE TEACHERS

"WHEREAS, the teachers of the Ormoc City High School have been clamoring for the national share of their salaries covering the period from the last quarter of 1981 up to the present so much so that they have sought the intercession of this august Body to appeal, for and in their behalf, to the National Government for the immediate release of the 40% share of their salaries while the City Government has been fulfilling its obligation to share the 60%;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded jointly by Mga Kagawad Torrevillas and Bandalan; be it

"RESOLVED, to respectfully request the Honorable Minister of Education and Culture to expedite the release of the 40% national share of the Ormoc City High School Teachers' salaries covering the period from the last quarter of 1981 up to the present in order to alleviate the financial suffering of the teachers; and be it

"RESOLVED, FURTHER, to reflect this resolution in a telegram to the Honorable Minister of Education and Culture followed by a copy hereof and; also, furnish a copy of this resolution to the Principal, Ormoc City High School;

"CARRIED UNANIMOUSLY."
