RESOLUTION NO. 1137

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE MINISTER OF
EDUCATION AND CULTURE TO ESTABLISH IN ORMOG CITY VOCATIONAL
AND TECHNICAL SCHOOLS IN THE SECONDARY SCHOOL AND COLLEGE
LEVELS TO SERVE ALSO NEIGHBORING MUNICIPALITIES

"WHEREAS, it has been long the desire of the Administration for
the establishment of vocational and technical schools in view of the
ever growing number of elementary and high school graduates who can-
not pursue higher education but might as well buckle themselves to
vocational or technical studies whenever available, more so nowadays
that Ormoc, besides being an agricultural city, is fast becoming an
industrial center that will be needing vocational and technical man-
power not only from and within this locality but also from the neigh-
boring towns, north to south;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded unani-
mously by all the other Mga Kagawad present; be it

"RESOLVED, to earnestly request the Honorable Minister of Edu-
cation and Culture to establish in the City of Ormoc vocational and
technical schools in the secondary school and college levels which
schools will also serve the neighboring municipalities from north
to south; and be it

"RESOLVED, FURTHER, to furnish Hon. Onofre D. Corpuz, Minister
of Education and Culture, in Metro Manila a copy of this resolution;
"CARRIED UNANIMOUSLY."


