RESOLUTION NO. 1139

A RESOLUTION EARNESTLY REQUESTING THE INTERVENTION OF THE HONORABLE
MINISTER OF TRANSPORTATION AND COMMUNICATIONS FOR CONTINUATION OF
LONG DISTANCE SERVICE OF THE ORMOC CITY TELEPHONE COMPANY,
OTHERWISE, RESTORE THE GOVERNMENT TELEPHONE SERVICE OF THE
BUREAU OF TELECOMMUNICATIONS IN THE CITY OF ORMOC

"WHEREAS, the Ormoc City Telephone Company has abolished its long
distance service much to the prejudice and detriment of the Ormocanos
such that they are now clamoring for the continuation of this very in-
dispensable system of communication to and from the outside world;

"WHEREAS, the people are recalling that it was by far better in
the recent past when also the government telephone system was in ope-
ration because there was always a long distance service offered by
both entities than at present where there is only the private company
which, without a moment's notice, abolished its long distance service
so much so that the people believe that if the Ormoc City Telephone
Company, a private enterprise, cannot revive its long distance service
it would be better if the government telephone service of the Bureau
of Telecommunications would be restored;

"NOW, THEREFORE, on motion of Kagawad Santiago, seconded by Ka-
gawad Torrevillas; be it

"RESOLVED, to earnestly request the intervention of the Honorable
Minister of Transportation and Communications for the continuation of
the long distance service of the Ormoc City Telephone Company, a pri-
vate enterprise, otherwise, restore the Government Telephone Service
of the Bureau of Telecommunications in the City of Ormoc, and do, as
this Body hereby does reflect this resolution in a telegram; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the Honorable Minister of Transportation and Communications, Metro Ma-
nila; the Regional Director, Bureau of Telecommunications, Tacloban
City; the Station Manager, Bureau of Telecommunications, and the Ge-
neral Manager, Ormoc City Telephone Co., both in Ormoc City;

"CARRIED UNANIMOUSLY."
