RESOLUTION NO. 1140

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST  
CURRENT APPROPRIATIONS ON ILLUMINATION AND POWER OF DIFFERENT  
OFFICES THE AGGREGATE SUM OF P38,542.46 TO SETTLE OUTSTANDING  
OBLIGATIONS WITH LEYECO V INCURRED IN PRIOR YEARS

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Besa-  
bella, seconded jointly by Mga Kagawad Mendola and Torre Villas;

"RESOLVED, to authorize the City Treasurer to charge against cur-  
rent appropriations on illumination and power of different offices the  
aggregate sum of THIRTY-EIGHT THOUSAND FIVE HUNDRED FORTY-TWO & 46/100  
PESOS (P38,542.46), said sum or so much thereof as may be necessary to  
be made available for settling outstanding obligations with LEYECO V  
incurred in prior years, to wit:
