RESOLUTION NO. 1148

A RESOLUTION EARNESTLY REQUESTING THE REGIONAL DIRECTOR OF EDUCATION AND CULTURE TO AUTHORIZE THE ASSISTANT, VICE - THE SCHOOLS DIVISION SUPERINTENDENT OF ORMOC CITY, TO SIGN PAPERS INASMUCH AS THE CITY TREASURER DISREGARDS PAPERS, SPECIALLY HIGH SCHOOL PAYROLLS, SIGNED BY SUPERINTENDENT CIRILO M. ZANORIA WHOSE EXTENSION OF SERVICE FROM RETIREMENT DATE, ACCORDING TO THE CITY TREASURER, IS NOT SANCTIONED OR AUTHORIZED BY THE OFFICE OF THE PRESIDENT UNDER ITS UNNUMBERED MEMORANDUM CIRCULAR DATED MARCH 5, 1958.

"WHEREAS, teachers and office personnel of the Ormoc City High School cannot be paid their salaries and wages because the City Treasurer would not act on their payrolls signed by Mr. Cirilo M. Zanoria whose extension of service beyond retirement as Schools Division Superintendent, according to the City Treasurer, is not sanctioned or authorized by the Office of the President under its Unnumbered Memorandum Circular dated March 5, 1958;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded unanimously by all the other Mga Kagawad; be it

"RESOLVED, to earnestly request the Regional Director, Ministry of Education and Culture, to authorize the Assistant Schools Division Superintendent, Mr. Pedro N. Compendio, to sign papers inasmuch as the City Treasurer will disregard papers, specially payrolls, signed by Mr. Cirilo M. Zanoria whose extension of service from the date of his retirement as Schools Division Superintendent of Ormoc City, according to the City Treasurer, is not sanctioned or authorized by the Office of the President under the latter's Unnumbered Memorandum Circular dated March 5, 1958, in order not to prejudice the teachers and office personnel of the Ormoc City High School and do, as this Body hereby does, reflect this resolution in a telegram to the Regional Director; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Regional Director, Ministry of Education and Culture, the Regional Director, Civil Service Commission, and the Regional Director, Ministry of Finance, all in Tacloban City; the Schools Division Superintendent, the Assistant Schools Division Superintendent, and the City Treasurer, all in Ormoc City;

"CARRIED UNANIMOUSLY."
