RESOLUTION NO. 1149

A. RESOLUTION LIMITING PAYMENT BY THE CITY FOR ELECTRIC CURRENT
FOR ONLY 250 WATTS FOR EVERY BARANGAY AND ANY WATTAGE IN
EXCESS THEREOF SHALL BE PAID BY THE BARANGAY OUT OF ITS TEN
PERCENT (10%) REALTY TAX SHARES OR FROM OTHER SOURCES AMEND-
ING, FOR THIS PURPOSE, RESOLUTION NO. 939 OF FEBRUARY 10, 1981

"WHEREAS, Resolution No. 939 of this august Body limits payment
by the City for electric consumption for five (5) units of incandes-
cent or mercury lamps for every barangay where it should have been
any number of units provided they will not exceed 250 watts and any
wattage in excess shall be paid by the barangay out of its ten per-
cent (10%) realty tax shares or from any other source;

"NOW, THEREFORE, On motion of Kagawad Samson, seconded by Ka-
gawad Santiago; be it

"RESOLVED, to limit payment by the City for electric current
for only 250 watts for every barangay and any wattage in excess
thereof shall be paid by the barangay out of its ten percent (10%)
realty tax shares or from any other source amending, for this pur-
pose, Resolution No. 939 dated February 10, 1981; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the General Manager, LEYECO V, the City Treasurer, the City En-
gineer, the City Auditor, and all Barangay Captains, in the City of
Ormoc;

"CARRIED UNANIMOUSLY."
