RESOLUTION NO. 1152

A RESOLUTION OF INQUIRY TO THE HONORABLE COMMISSION ON
ELECTIONS PERTINENT TO THE STATUS OF ABC PRESIDENT
ROMEO M. HERMOSILLA AS KAGAWAD NG SANGGUNIANG PANLUNGSOD
UPON FILING CERTIFICATE OF CANDIDACY FOR PUNONG BARANGAY

"WHEREAS, this august Body is somewhat in a quandary as to the
status of our esteemed colleague, the Honorable Romeo M. Hermosilla,
ABC President and concurrently Kagawad ng Sangguniang Panlungsod, as
soon as he files his certificate of candidacy for Punong Barangay;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded by Kaga-
wad Bandalan; be it

"RESOLVED, to inquire from the Honorable Commission on Elections
pertinent to the status of the Honorable ABC President Romeo M. Her-
mosilla as Kagawad ng Sangguniang Panlungsod as soon as he files his
certificate of candidacy for Punong Barangay whether he is considered
automatically resigned or just on forced leave and, if considered as
on forced leave, he is entitled to emoluments for the duration of his
forced leave and shall return to his office as Kagawad representing
the Association of Barangay Councils until he or his successor quali-
fies for the position of Kagawad ng Sangguniang Panlungsod; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the Honorable Commission on Elections, Metro Manila; the City Election
Registrar and the City Development Officer, both in Ormoc City;

"CARRIED. Six affirmative votes; one abstention registered by
Kagawad Hermosilla."
