RESOLUTION NO. 1153

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION ON RESERVED FOR EXPROPRIATION OF LOTS FROM THE CONTINUING ALLOTMENT UNDER INFRASTRUCTURE FUND THE AGGREGATE SUM OF P201,094.66 FOR PAYMENT TO LANDOWNERS AFFECTED BY THE DECISION IN SPECIAL CIVIL CASE NO. 711-O, FOR EMINENT DOMAIN, IN CONNECTION WITH THE GOVERNMENT CENTER ESTABLISHMENT

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Besabella, seconded by Kagawad Mendola;

"RESOLVED, to authorize the City Treasurer to charge against current appropriation on Reserved for Expropriation of Lots from the continuing allotment under Infrastructure Fund, the aggregate sum of Two Hundred One Thousand Ninety-Four & 66/100 Pesos (P201,094.66), said sum or so much thereof as may be necessary to be made available for payment to landowners affected by the decision in Special Civil Case No. 711-O, for Eminent Domain, in connection with the government center establishment; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Auditor, the City Budget Officer, the City Legal Officer and the City Engineer, all in Ormoc City.
