RESOLUTION NO. 1156

A RESOLUTION TO AUTHORIZE THE HONORABLE CITY MAYOR TO ACCEPT
THE DONATION OF TWO 80-WATT BALLASTED TYPE MERCURY LAMPS
BY THE RESIDENTS OF BARANGAY BAGONG BUHAY FOR INSTALLATION
IN SAID BARANGAY

"WHEREAS, some twenty-seven residents of Barangay Bagong Buhay have jointly expressed their desire to donate two units of mercury vapor lamps, 80-watt, ballasted type to be installed in said barangay, to allay fear and apprehension among themselves that some bad elements might avail of the darkness in their area for the commission of crimes;

"WHEREAS, this august Body finds the donation acceptable on condition that the said installation shall be maintained by the Barangay Council of Bagong Buhay in pursuance of the policy of the City Administration;

"NOW, THEREFORE, on motion of Kagawad Santiago, duly seconded by Kagawad Bandalan; be it

"RESOLVED, to authorize the Honorable City Mayor to accept the donation of two units of 80-watt ballasted type mercury vapor lamps by the residents of Barangay Bagong Buhay for installation in said barangay and do, as this Body hereby does, express our heartfelt gratitude to the donors for their civic-mindedness; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the General Manager, LEYECO V, the President, Board of Directors, LEYECO V, the City Treasurer, the City Engineer, and the Barangay Council of Bagong Buhay, all in the City of Ormoc;
