RESOLUTION NO. 1157

A RESOLUTION TO APPROVE THE ESTABLISHMENT OF PHILIPPINE COAST GUARD
HEADQUARTERS ON A PORTION OF LOT BETWEEN THE PPA OFFICE AND THE
ORMOC PIER AT THE SHORE PROTECTION DEVELOPMENT AREA
FRONTING THE BUS TERMINAL BUILDING NO. 2

"WHEREAS, there has been a long pending request of the Coast Guard
Station Commander for a portion of lot in the port area for the estab-
lishment of their headquarters, a priority construction project of the
Philippine Coast Guard since 1980, inasmuch as Ormoc City has been se-
lected as a maritime port, and the said headquarters will include the
administration building, personnel barracks, and other facilities to
support the operational requirements of his command;

"WHEREAS, the City Engineer, after having made an ocular inspection
jointly with the Honorable Vice-Mayor and the Coast Guard Station Comman-
der, recommended that portion of lot between the office of the Philippine
Ports Authority (PPA) and the Ormoc pier at the shore protection develop-
ment area fronting Bus Terminal Building No. 2 which is acceptable to the
commander, and this august Body interposes no objection to such establish-
ment considering that it will not only further develop and improve the
area but also enhance the beautification of the place;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded by Kagawad
Bandalan; be it

"RESOLVED, to approve the establishment of the Philippine Coast Guard
headquarters on a portion of lot according to their needs between the PPA
office and the Ormoc pier at the shore protection development area front-
ing the Bus Terminal Building No. 2; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the
City Engineer, the City Development Coordinator, and the Station Commander,
2nd Coast Guard District, Philippine Coast Guard, all in Ormoc City;
"CARRIED UNANIMOUSLY."
