RESOLUTION NO. 1159

A RESOLUTION FAVORABLY ENDORSING TO THE HONORABLE CITY MAYOR THE
REQUEST OF THE FOUNDATION FOR THE REHABILITATION AND PREVENTION
OF BLINDNESS IN THE PHILIPPINES, INC., FOR A PERMIT TO HOLD A
THREE-DAY "PINTAKASI" (MAY 27-28-29, 1982) AT THE NADUNGHOLAN
COCKPIT TO RAISE FUNDS FOR ITS MULTIPAROUS HUMANITARIAN PROJECTS

"WHEREAS, the Honorable City Mayor has forwarded to this august Body
the letter dated May 7, 1982, of the Regional Coordinator of the Founda-
tion for the Rehabilitation and Prevention of Blindness in the Philippines,
Inc., requesting a permit to hold a three-day 'pintakasi' in line with Pro-
vidential Proclamation No. 2117 authorizing the Foundation to conduct any
kind of fund raising activities as it needs the financial and moral support
of the public;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded jointly by Mga
Kagawad Torrevillas and Santiago; be it

"RESOLVED, to favorably endorse to the Honorable City Mayor the re-
quest of the Regional Coordinator, Foundation for the Rehabilitation and
Prevention of Blindness in the Philippines, Inc., for a permit to hold
a three-day 'pintakasi' on May 27-28-29, 1982, at the Nadungholan Cockpit,
a duly licensed establishment in Ormoc City, to raise funds for the Foun-
dation's multifarious humanitarian projects; and be it

Proprietor, Nadungholan Cockpit, both in the City of Ormoc;
