A RESOLUTION AUTHORIZING THE CITY TREASURER TO RELEASE THE SUM
OF ₱51,750.00 OUT OF THE ITEM ON ACQUISITION OF ROAD RIGHT
OF WAY TO PAY 1,725 SQUARE METERS OF BENJAMIN PARRILLA'S
LOT NO. 2363-A VALUED AT ₱30.00 PER SQUARE METER AFFECTED BY
THE PROPOSED ROAD CONSTRUCTION CONNECTING BARANGAY DOÑA
FELIZA Z. MEJIA TO DON FELIPE LARRAZABAL STREET

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Men-
dola, seconded by Kagawad Hermosilla;

"RESOLVED, to authorize the City Treasurer to release the sum
of Fifty One Thousand Seven Hundred Fifty Pesos (₱51,750.00) out of
the item on Acquisition of Road Right of Way to pay one thousand se-
ven hundred twenty-five (1,725) square meters of Benjamin Parrilla's
Lot No. 23-63-A which lot is valued at Thirty Pesos (₱30.00) per
square meter and is affected by the proposed construction of a road
that will connect Barangay Doña Feliza Z. Mejia (formerly Barangay
Tuog) to Don Felipe Larrazabal Street; and

to the City Treasurer, the City Auditor, the City Budget Officer,
the City Engineer, and Mr. Benjamin Parrilla, all in the City of
Ormoc;
