THE 20% DEVELOPMENT FUND ON AUTHORITY OF THE MINISTRY  
OF LOCAL GOVERNMENT TO BE MADE AVAILABLE FOR ADDITIONAL  
APPROPRIATION FOR THE REPAIR OF THE ROOFING OF THE  
FISH AND MEAT SECTION OF THE PUBLIC MARKET COMPLEX
