RESOLUTION NO. 1171

A RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY,
PRESIDENT FERDINAND E. MARCOS, TO APPOINT ENGR. SALVADOR S.
SANTIAGO AS PERMANENT CITY ENGINEER OF ORMOC CITY AFTER HAVING
BEEN DESIGNATED AS OFFICER-IN-CHARGE FOR SIX YEARS OF THE
CITY ENGINEERING DEPARTMENT

"WHEREAS, Mr. Salvador S. Santiago, Highway District Engineer II,
having served for the last six years by virtue of his designation as
Officer-in-Charge of the Ormoc City Engineering Department, and who,
to the honest belief of this august body, rightfully deserves a perma-
nent appointment as City Engineer, and in such case, the City can avail
itself of his expertise, industry, and diligence in the prosecution of
the various projects resulting to the greater benefit and welfare of
the City of Ormoc;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded unani-
mously by all the other Mga Kagawad; be it

"RESOLVED, to earnestly request His Excellency, President Fer-
dinand E. Marcos, to appoint Engr. Salvador S. Santiago as permanent
City Engineer of Ormoc after having been designated for six years as

Honorable Emiliano Melgazo, Alberto A. Veloso, Artemio Mate, Damian
Aldaba, and Nicanor Yñiguez of Southern Leyte, all of the Batasang
Pampansa, Metro Manila; and to Engr. Salvador S. Santiago, Officer-In-
Charge, Engineering Department, Ormoc City;
