THE 1982 ORMOC CITY FESTIVAL CELEBRATION

"WHEREAS, not a few cockfight aficionados have made representations with the City Administration that derbies be held on June 26 and 29 in connection with our celebration of the 1982 Ormoc City Festival; and

"WHEREAS, this august Body finds the request most worthy of consideration taking into account that cockfight is a national game and has been a part of our tradition for centuries so much so that fiestas in every nook and cranny of the archipelago are celebrated with cockfights among the highlights of the jubilee;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded unanimously by all the other Mga Kagawad; be it
