A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT  
THE DONATION OF 9 UNITS OF MERCURY LAMPS FROM THE OFFICIALS  
AND RESIDENTS OF BARANGAY XXII FOR INSTALLATION ON  
STRATEGICALLY LOCATED ELECTRIC POSTS PROVIDED THEY SHALL BE  
INSTALLED ALTERNATELY ON ONE POST AFTER ANOTHER

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Bandalan,
