RESOLUTION NO. 1181

A RESOLUTION EARNESTLY REQUESTING THE REGIONAL PORT MANAGER FOR  
THE DECONGESTION AND CLEANING UP OF THE ORMOC PIER FOR THE SAFETY  
AND CONVENIENCE OF BOAT PASSENGERS, PEDESTRIANS, AND VEHICLES

"WHEREAS, the Ormoc Pier has become quite an unsightly jumble of  
crates and other various cargoes remaining for days, including contain-  
er vans at times, from end to end with a seemingly ill kept and worn out  
PPA outpost at the middle of said pier, not to mention the dirt and the  
waste materials that litter all along;

"WHEREAS, this almost everyday occurrence has been posing a danger,  
discomfort and inconvenience to boat passengers, pedestrians and vehicles  
alike; even as the mess constitutes an eyesore to visitors and travelers;

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded unanimous-  
ly by all the other Mga Kagawad; be it

"RESOLVED, to earnestly request the Regional Port Manager for the  
decongestion and cleaning up of the Ormoc pier for the safety, comfort  
and convenience of boat passengers, pedestrians, and vehicles; and let  
this resolution be immediately conveyed in a telegram for prompt res-  
ponse and immediate action; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to  
the General Port Manager, P.O. Box 62, Manila; the Regional Port Mana-  
ger, PPA, Tacloban City; and the Officer-In-Charge, Philippine Ports  
Authority, Ormoc City;
